The persons so designated above will be eligible to wear the uniform of the prescribed post. They will not be eligible for higher pay and allowances other than what they would have received. They will be accommodated among the available sanctioned posts in the rank of regular CPO and are also responsible to discharge the duties of the actual post. They will not have any claim of seniority in the designated category. The persons who are designated as SCPO(Grade) will be promoted to the cadre of SCPO as and when their turn comes in the regular line of promotion unless they found ineligible and strictly on the basis of their position in the seniority list of regular CPOs. This order will not alter the existing rules with regard to the disciplinary authority under KPDIP & A Rules & MDP. If any one is found ineligible for grade promotion in future, they will be reverted without further notice.
