Sub : Seniority dispute between directly recruited AR personnel and APBn personnel -Stagnation in promotion - Temporary Promotion of CPOs as SCPO - Orders issued.

The seniority dispute between AP Battalion personnel and directly recruited District AR Personnel has resulted into stagnation of promotion in the cadre of SIs/ASIs/SCPOs in the Kerala Police Wing. The matter is now under consideration of the Hon'ble High Court. The deadlock in promotions also blocked the recruitment of CPOs.

A meeting held at PHQ on 07.02.2018 to discuss about the stagnation in promotion in the cadre of SIs/ASIs/SCPOs as a result of the seniority dispute between AP Bn Personnel and directly recruited AR personnel. In order to overcome the present situation, the following actions are recommended:-

- 1.The regular vacancies of SCPOs, if any remaining in the districts has to be filled up immediately by observing the rules and procedure.
- 2.The combined vacancies in the Rank of "Promotee SI+ ASI + SCPO" may be temporarily treated as vacancy in the cadre of SCPOs in the district and promotion of that many CPOs may be given for the time being.
- 3.The eligible CPOs from the select list has to be promoted to the cadre of SCPOs on a temporary basis against the notional SCPO vacancy calculated as above.
4. The resultant vacancies of the CPOs in districts has to be evaluated and reported to ADGP (APBn) for KCP transfer from Battalions.

In the above circumstances, the following CPOs (GE) who are included in the select list of CPOs (GE) fit for promotion as SCPOs (GE) are temporarily promoted as SCPOs (GE) against the existing vacancies of SCPOs/ASIs/ Promotee SIs, considering the administrative exigencies and allotted to Thrissur Rural . Their posting orders will be issued later.
