They will be accommodated among the available sanctioned posts in the rank of regular CPO and are also responsible to discharge the duties of the actual post. They will not have any claim of seniority in the designated category. The persons who are designated as SCPO(Grade) will be promoted to the cadre of SrCPO as and when their turn comes in the regular line of promotion unless they found ineligible and strictly on the basis of their position in the seniority list of regular CPOs. This order will not alter the existing rules with regard to the disciplinary authority under KPDIP & A
