The promoted SCPOs will be on probation for a period of one year on duty within a continuous period of two years from the date of joining duty/date of regularization of promotion whichever is later. All these promotions will be subject to such conditions as may be prescribed by the Govt. with regard to the integration of AR cadre with General Executive (KCP). The promotees shall exercise options for fixation of their pay in the higher time scale under Rule 28 A Part I KSRs, within one month from the date of order, as prescribed in the relevant Govt. Orders. The SHOs/Controlling officers should relieve the promotees for effecting the promotion with direction to report before the concerned authority after issuing the posting order of promoted SCPOs from this unit. If any of them is under suspension, he should not be permitted to assume charge as SCPO and such cases will be reported to this office. All of the above promotion and posting are done giving emphasis to filling up of existing vacancies as per orders of Hon'ble High Court and the direction from PHQ.
