The persons so designated above will be eligible to wear the uniform of the prescribed post. He will not be eligible for higher pay and allowances other than what they would have received.He will be accommodated among the available sanctioned posts in the rank of regular ASI and are also responsible to discharge their duties of the actual post. He will not have any claim of seniority in the designated category. The person who is designated as GSI will be promoted to the cadre of SI as the case may be as and when his turn comes in the regular line of promotion unless he found ineligible and strictly on the basis of his position in the seniority list of regular ASI/SCPO and on the basis of the recommendations of DPB. This order will not alter the existing rules with regard to the Disciplinary Authority under KPDIP&A Rules & MDP. This means that the GSIs will be treated as regular ASI as the case may be in respect of any departmental action as per KPDIP&A Rules. If anyone is seen included in this list erroneously, their grade promotion will be liable for cancellation without prior notice.
