Sub : Designating police personnel as Sub Inspector of Police (Grade) - Orders issued.

In pursuance of the orders issued as per the references cited, the following police personnel of this unit are designated as Sub Inspector of Police (Grade) with effect from the dates noted against them, subject to the following conditions.

1) The regular ASI / ASI (Grade) must have completed 25 years of service including the period of basic training. The period spent by an officer under suspension as part of disciplinary proceedings which is counted as duty for the limited purpose of giving pension and gratuity amount and the period of LWA availed for employment abroad etc. will be excluded from the total qualifying service for calculating the minimum mandatory service of 25 years for designating as Sub Inspector of Police (Grade).

2) The regular ASI / ASI (Grade) must be drawing pay in a pay scale equal to or higher than that of Sub Inspector of Police.

3) The regular ASI / ASI (Grade) who is designated as Sub Inspector of Police (Grade) will be promoted to the cadre of Sub Inspector of Police (KCP) / Asst. Sub Inspector of Police (KCP) as and when his turn comes in the regular line of promotion unless he is found ineligible.

4) The senior most regular SI / ASI will be entrusted with the SHO duties in the absence of a regular Station House Officer. The Sub Inspector of Police (Grade), if available, will be assigned the charge of SHO during the period of absence of a regular SI or there are no SIs senior to him available.

5) A Sub Inspector of Police (Grade) will be assigned all duties of an Addl. Sub Inspector of Police as stipulated in the Police Standing Orders under the overall control and command of the Station House Officer. When an SCPO / ASI (Grade) designated as SI (Grade) is present along with a regular ASI in the same Police Station, there may arise situations where some of the regular ASIs are senior to the Grade Designated SIs. In such cases, internal arrangements will be made to avoid problems regarding charge assignments of SHO by ensuring that such senior most regular ASIs are not posted in the same station without their consent.


6) The persons so designated will be eligible to wear the uniform of a regular Sub Inspector of Police.

7) They will not be eligible for higher pay and allowances other than what would have been received if they were not designated as Sub Inspector of Police (Grade).

8) A regular ASI designated as SI (Grade) will be accommodated among the available sanctioned posts of Asst. Sub Inspector of Police (KCP) till he attains promotion as SI as per his cadre seniority. An ASI (Grade) designated as SI (Grade) will be accommodated in the sanctioned post of SCPOs and will be promoted as ASI and SI in due course as per cadre seniority.

9) They will not be eligible to claim seniority in the cadre of SI of Police (KCP) based on their grade designation.
