Following Civil Police Officer of Thrissur Rural District who is under orders of transfer to Thiruvananthapuram District on an Inter-District Transfer basis as per DO referred above is relieved off his duties in this unit with immediate effect. He will be the junior most CPO in Thiruvananthapuram District (KCP) and his seniority in Thiruvananthapuram District will be reckoned only from the date of his joining duty in Thiruvananthapuram District.
