Sub : General Transfer 2025 - Transfer and posting of Senior Civil Police Officers (SCPOs) - Orders issued.

The following Senior Civil Police Officers of this district are transferred and posted to the stations/offices noted against them with immediate effect, considering their options preferred, availability of vacancies in stations, for administrative convenience, and in public interest. The transferees will assume charge in the new stations/offices within one week positively. Officers concerned will relieve/admit the individuals immediately, update the details in the iAPS Strength Management Module, e-Roll, and will report compliance by return.

In exercise of the powers conferred to the transferring authority as per Rule 127, Part I of KSR, to reduce the period of joining time in special circumstances, **joining time for the following transfers and postings is limited to 3 days**, including preparation time. F1 / F2 sections will check the attendance statements in respect of the individuals for the concerned month and will intimate details of excess joining time, if any, to A5 / A6 sections.
