- Sub : Police Estt - Declaration of Probation of the Police personnel who are appointed after 31.01.2011 - treating the period of training as officiating service for the purpose of probation on completion of training - Revised - Orders issued
- Ref : 1. GO(Ms) No.179/2020/Home dated 24.09.2020.
 2. Govt. letter No. A6/240/2018/Home dated 17.11.2021.
 3. PHQ letter No. E8/122148/2020/PHQ dated 15.12.2021.

As per the Government order cited 1st, which is a clarification to section 88 (2) of the Kerala Police Act 2011 has effect from 31.01.2011(the date of notification of Police Act) , the period of training including examination and extended period of training, if any, shall be treated as officiating service for the purpose of probation, increment and pension, on completion of training. During the training prescribed under section 88(2) of the Kerala Police Act 2011, the trainees are entitled to stipend equal to the minimum of the basic pay of the post to which they are selected. The government, vide letter cited 2nd , have also clarified that the provisions contained in the G.O cited has to be implemented with effect from 31.01.2011.

Now, PHQ vide letter cited 3rd, has instructed to take necessary action to implement the G.O cited 1st , in the case of those who are appointed after 31.01.2011 and to revise the service benefits already given, according to the order. As per the above Govt. order cited 1st ,the period of probation in r/o police personnel who are appointed after 31/01/2011 is commenced wef. the date of joining for training.Probation period in the cadre of CPOs is two years on duty within a continuous period of three years.Accordingly the date of completion of period of probation in r/o the following 5 police personnel of this unit whose probation has already been declared has to be revised.

On verification of their Service records it is seen that there are no adverse remarks against them during their period of probation , as they have successfully completed their training vide the order shown in column No.12 and satisfactorily completed their probation previously vide the order shown in columns 10 &11, further remarks in this regard is not required. The Interruption during the period of probation due to leave etc are shown in column No.8.

Accordingly, the date of declaration of probation of the following 5 Police personnel of this unit , who were relegated from training and reappointed wef date mentioned in the column no.6 , is revised and modified with effect from the dates mentioned in column No.13.
